- The flueless patio horizon gas fireplace come standard with, fireplace casing with porcelain liners, 304 grade stainless steel burner (72Mj) glass bead media, glass fender and on / off wall switch.
- As per the diagram this can be installed into a timber framework with a non combustible zone of 150mm above the top of the fireplace where a minimum 9mm fibre cement sheeting is to be used to clad wall.
- 50mm clearance from sides and back of appliance to any combustible material.
- This unit can only be installed into an <u>outside area with sufficient ventilation</u> as per gas regulations (minimum 2 open sides).
- This unit is battery pack operated using 2x D size batteries.
- To change batteries, burner will need to be removed to access battery pack.
- AC adaptor included to convert unit to 240v ignition.
- Ignition on / off switch is located on right hand side of the firebox. This can be extended to a more user friendly location.

<u>IMPORTANT</u>: There must be sufficient drainage under all appliances to allow for water and excess moisture to completely dry so components are not affected

IMPORTANT:


Installation of this appliance should only be carried out by an authorised person in accordance with the manufacturers instruction. All relevant codes and regulations laid down by the gas authorities uniform building regulations and the requirements of local municipal authorities must be observed. Appliance installation must comply with AS5601/AG5601 clause 5.12.13.2 and 5.12.13.5.


Refer to the data plate for information in respect of gas type, Natural and LPG (propane). The data plate is located on the base of unit and is accessed by opening




DIMENSIONS



NOTE: THE FLEX LINE INLET TO THE VENTURI MUST HAVE A GOOSE NECK BEND TO PREVENT WATER FLOWING TO THE VALVE






NOTE: MINIMUM CLEARANCE REQUIRED FROM THE UNDERSIDE OF THE MODULE BOX UPON INSTALLATION




NOTE: The example cut outs shown on this face also needs to be installed on the adjacent face.


NOTE:

- DRAINAGE AND THROUGH VENTILATION IS NECESSARY TO THE CONSTRUCTION / HOUSING OF THE RECTANGLE BURNER.
- THE MINIMUM VENTILATION HOLES NEEDS TO BE 2.5% OPEN AREA PER HOLE OF THE 2 LARGEST SIDES. SEPARATE DRAINAGE HOLES AT ALL CORNERS ARE ALSO NECESSARY TO AVOID MOISTURE RETENTION. BASE FLOOR MUST NOT BE ABLE TO HOLD MOISTURE. Eg. 2x1 m² SIDES TO EACH HAVE 25000 mm² OPEN VENTILATION TOP AND ALSO BOTTOM. THIS MUST BE PROPORTIONATELY ADJUSTED TO THE STRUCTURE SIZE






NOTE: The example cut outs shown is the minimum requirement according to the height and width of the panel 25000 mm² hole can be eg. 100x250 / 70x357 / 25x1000mm Ensure the floor material does not retain moisture.





VENTILATION




NOTE: The example cut outs shown on this face also needs to be shown on the adjacent face.


NOTE:

- DRAINAGE AND THROUGH VENTILATION IS NECESSARY TO THE CONSTRUCTION / HOUSING OF THE ROUND BURNER.
- THE MINIMUM VENTILATION HOLES NEEDS TO BE 2.5% OPEN AREA PER HOLE ON BOTH SIDES. FOUR SEPARATE DRAINAGE HOLES ARE ALSO NECESSARY TO AVOID MOISTURE RETENTION. BASE FLOOR MUST NOT BE ABLE TO HOLD MOISTURE.






NOTE: The example cut outs shown is the minimum requirement according to the height and area of half of the stand diameter. 17000 mm2 (based on 2.5% half of diameter face of stand) eg. 170x100 / 340x50mm Ensure that the floor material that does not retain moisture.









AC ADAPTOR RETRO FIT

- 1. Remove burner tray from outdoor patio fire, by lifting it up and out through the front of unit.
- 2. Turn burner tray upside down until the module is visible.

NOTE: The transformer power supply and battery pack must be boxed or covered and protected from moisture. This must be done prior to completion of installation and use.



AC Adaptor plug – female connector

 Using the multi voltage switchmode AC adaptor supplied, choose the appropriate adaptor plug, make sure to push cord from outside of box through the outer box holes and connect to female connector on the module. <u>Ensure that the AC adaptor is covered from above and no water can flow to it.</u> Use of covered IP66 or equivalent rated socket power point recommended.

AC adaptor supplied must be set to 3V

4. Make sure to remove the batteries, plug power cord to the nearest power point and test for spark.



5. Re- assemble burner tray back into the unit. 22/09/2020




AC adaptor plug 11








FRONT VIEW




PATIO HORIZON PANORAMIC MASONRY DIMENSIONS






PATIO HORIZON PANORAMIC MASONRY TRIM OPTION













STABILITY:

FIX THE UNIT TO THE GROUND AS REQUIRED







NOTE:

- POSITION THE UNIT IN THE REQUIRED AREA.
- REMOVE THE TABLE TOP TO EXPOSE THE FEET OF THE APPLIANCE. LOCATE HOLES AS SHOWN.
- USE THE EXISTING HOLES AND DRILL WITH CONCRETE DRILL BITS TO THE REQUIRED DEPTH. REPEAT PROCESS AS REQUIRED.
- PUSH CORRESPONDING DYNABOLTS INTO THE DRILLED HOLE/S AND TIGHTEN.
- THE UNIT SHOULD NOW BE STABILISED AND WILL NOT TILT ON A SIDE TO SIDE MOTION.












PATIO HORIZON REMOTE CONTROL PROGRAMMING

Programming a Remote:

An optional remote burner controller can be purchased for this product. This remote uses one <u>A23</u> battery (Not Included)

- 1. Begin with the CF-DSI control switch in the **Remote** Operation position.
- To program your remote, locate the program button on the *Control Module* (shown at right) and press it with a paper clip or similar small object. A single beep should be heard.
- 3. Press and hold the SET button on your remote until a series of beeps are heard from the *Control Module*. The remote is now paired with your burner.






Program button LED indicator



FIGURE E1 - OUTDOOR AREA – EXAMPLE 1









FIGURE E2 - OUTDOOR AREA - EXAMPLE 2
